22/010/01 Phone Box - Update, repairs and siting

22/010/02 Village Centre Project - Update

22/010/03 New swing for Jubilee Gardens - Parish Post/BPC Website

This would save money by not having to subscribe to a printing site in order to produce the Parish Post. 22/010/04 Speed indicator Devices

The Clerk has spoken to member of Dulverton Town Council and has been informed that Dulverton have an SID, would the Councillors like the Clerk to follow up on sharing this or get their own? This information is incorrect therefore the Clerk will continue with the purchase of their own.

22/010/05 Carnarvon Bridge outside Fairfield House

The Clerk has taken photos of the Bridge and emailed them, along with a description of the problems, to Somerset County Councils 'report a problem' page on their website. The response - 652117 has been emailed to all Councillors.

22/010/06 Emergency Planning (Parish Generator?)

In response to the storms that devastated the area recently the lack of electricity can mean no home phone usage, dependant on whether the householder has the copper wire or the new digital setup. Mobile phone masts can be affected by the loss of electricity. Various other Parishes are getting a generator to alleviate this problem. It was decided by the Councillors to think about this in the context of an emergency plan.

Open Reach have initiated a gain share project and have put together a plan to connect several properties in the Exe Valley onto Broadband.

There will be 48 road closure starting from the end of April until October all around the area some including Brushford. A member of the Open Reach team met with Councillor Nicholson to show the details of the list - Dulverton Town Council will have a meeting to discuss the signage relating to the road closures. Brushford Parish Councillors decided that Dulverton will encompass all the details that include the Brushford works.

After investigating this matter Councillor Nicholson found that Parishes had continued giving money to the Church for community benefit under the 1972 local government act.

Somerset West &Taunton's list of Parishes is missing the details of Brushford Parish Council, the Clerk will investigate.
