24/137 DECLARATIONS OF INTEREST

24/138 DEFERMENT OF BUSINESS

Several Parishioners attended the meeting with concerns over drivers speeding in the 30mph zone.

The attending residents of the Parish would like the Parish Council to recommend to Somerset Council that the speed limit is reduced as they feel very strongly that this issue needs looking at. The residents plan on getting partition together to send to Somerset Council.

Mrs Browring explained that whilst walking towards Ellersdown Lane two vehicles were speeding along the road, with one vehicle overtaking the other and narrowly missed colliding with Mrs Browring. All of the residents are extremely concerned that the speed of traffic is far too fast and the drivers are ignoring the 30mph sign. Mrs Browring also stated that whilst walking away from Travis Perkins on the correct side of the road, facing the oncoming traffic, Mrs Browring was verbally abused and insulted by a driver, who accused her of walking on the wrong side of the road. This was very upsetting for Mrs Browring who was acting correctly and it was the driver who was in the wrong.

Councillor Nicholson & Councillor Pugsley agreed to put these concerns to Somerset Councils Highways department before a petition is organised and will report back to Clerk who will the inform the residents of the outcome.

Councillor Nicholson said it will go to the highways subgroup, and that the general view that a speed limit of 60 mph will stand on stretches of road where there are no houses.

None received


