24/129/01 Jubilee Gardens Activity Centre

The Clerk gave the Councillors printouts of various different activity centres along with the costs in order for them to decide which one to have installed in the play area. The Councillors have taken the printouts home and will make their choices in time for the next meeting.

24/129/02 Village Centre Project

The Clerk has the contact details of a local builder and will make arrangements to meet him at the Nicholas Close site to discuss the redevelopment of the old bus shelter site as soon as possible.

24/131 SID DATA COLLECTION

The Clerk along with Councillor Albery tried to extract the data from the SID using both the Clerks and the Councillors computer but to no avail.

As the data can only be extracted using a Windows computer the Councillors gave their permission for the Clerk to purchase a small Windows Laptop for the sole purpose of SID data extraction onto a USB stick which can be offered to the Police for data analysis. The Clerk will purchase this in the near future.
