# 25/049/01 Jubilee Gardens Activity Centre

The Clerk met with the installers on Monday 16th June 2025, the multifunctional play set was installed and fenced off to protect it whilst it 'cured' The fencing, skip and temporary toilet were all removed by the following Tuesday (24th June). The new play equipment is already being enjoyed by the children of the village.

# 25/049/02 Basketball Court - Hoop Netting/Backboard renewal

The Clerk has spoken to the signage company and will measure the size of the backboards and the hoops and once theses measurements have been obtained will email the signage company for a quote and look online for new basket nettings.

# 25/049/03 Jubilee Gardens Play Area Acquisition

# 25/049/04 Trees in the Play Park

Three Atop started the arboreal work on Monday 7th July and completed it the following day, these trees only needed some of the smaller, lower branches removed.

## 25/049/05 Hornbeams at the Village Centre Project

Three Atop completed the removal of both Hornbeams on 8th July and cleared away all the debris. The Councillors approved this work and the payment of the Three Atop invoice.

## 25/049/06 Replacement Grit Bin at Iron Post

Councillor Albery has installed the new grit at the Iron Post site. He has kept the old grit bin for repair in order to put it to good use if required in the future.

#### 25/050 MAGNA HOUSING

The Clerk is awaiting a reply from Magna Housing regarding the email sent by the Clerk on 23/06/2025, Magna have stated they will reply within 21 working days with means a reply should arrive by the 23rd July 2025. If no such correspondence is received the Clerk will contact Magna Housing again about his matter.

The Clerk was requested to send an email to Magna Housing regarding their property at 17 Nicholas Close and the eviction of the late tenants family members, the email was drafted and after gaining final approval was sent. Councillor Pugsley has also been in communication with Magna Housing in relation to this matter.

Magna Housing have stated that they will review this situation given the level of local support shown for this family.

### 25/051 SID DATA COLLECTION

The Clerk emailed the Traffic Management Team, on Wednesday 25th June 2025, asking if they would like to have any downloaded data collected by the SID sent to them as a PDF file on a regular basis.
