23/087/01 Village Centre Project & S106 funding - update

23/088 CARNARVON STORES LICENCE REQUEST

Following an email from the owner of the Carnarvon Stores on 29/08/23 requesting the Councillors approval of a Liquor Licence for the Stores the Councillors decided to support this licence.

23/089 SULLYS LANE

Following on from minute number 23/074 the Clerk sent an email to the Councillors, with a photo depicting a wooden sign at the end of the lane which read SULLYS & LOWER SULLYS, asking if she should therefore continue pursuing costings for a new wooden sign.

There is no official name for the lane which is a byway open to all traffic leading to the properties Sully's, Lower Sully's, Sully's End and Ashcombe so the sign should include all the property names.

Any sign must read 'Leading to' then name all of the properties along the lane.

The Parish Council is not responsible for this signage, the Clerk will respond to the resident who requested the sign initially with all of this information.

23/090 SID UPDATE

Having not heard back from her first request for an update on the Speed Indicator Device application the Clerk has sent another email and this time copied in PC Michelle Haimes. Once a reply has been received she will inform the Councillors.

23/091 VOLUNTEER DRIVERS

After a discussion the Councillors decided against this as there is already a Volunteer drivers service, namely TA22 Drivers operating in Brushford

23/092 PLANNING APPLICATIONS

23/093 REPORTS FROM COUNCILLORS

Councillor Nicholson reported - Brushford road closure to go until the end of October, OpenReach should have finish their part by the end of this week, they want to come back into the Village in October and wish to shut Brushford New Road with a diversion which means drivers will have to use Ellersdown Lane or Back Lane which are both vey narrow. Councillor Nicholson proposed one lane to be used as one way in and the other lane as the way out of the Village. The Councillors have asked if the closure could be between 9am and 3pm with Back Lane used as the way in and Ellersdown Lane the way out. All this if traffic lights are an impossibility.

Regarding the Nicholas Close sign, Councillor Nicholson has spoken to the appropriate person at Somerset Council about the Nicholas Road sign as the sign is technically the responsibility of Somerset Council and as such they will pay for a new sign.

The Councillors have asked that Somerset Council provide and pay for the sign, providing Brushford Parish Council supply Somerset Council with a mock up drawing/design showing just what information is required on the sign.

Highways are taking over the checking and filling of grit bins also anybody can report an empty bin by using the portal on the Somerset Council website. The problems that could occur might be due to the Councils map of the bins not being accurate. Councillor Nicholson is working on making sure the Council has the correct information.
